Beryl is Professor of History at Rutgers University-Newark. Her book *Family Properties: Race, Real Estate, and the Exploitation of Black Urban America* (2009) won the Organization of American Historians' Liberty Legacy Award for best book in civil rights history and the Jewish




Book Council's National Jewish Book Award in History. It was a finalist for the J. Anthony Lukas Book Prize and for the Ron Ridenhouer Book Prize, awarded to "those that persevere in acts of truth-telling." She is a cofounder, with Darnell Moore and Christina Strasburger, of the Queer Newark Oral History Project.

Caronina has been a Program Officer at Woods Fund Chicago since 2013. As Program Officer, she shares responsibility for reviewing grant proposals, making informed funding recommendations to Woods Fund's Board of Directors, monitoring relationships with organizations that Woods Fund supports, and identifying





Lead Organizer Contract Buyers League

Jack was the lead organizer of the Contract Buyers League of Chicago, an organization of African-American homeowners who were gouged by unscrupulous real estate speculators when they bought their homes. The Contract Buyers League initiated two federal lawsuits and conducted a strategically planned payment strike. As a result, 450 families got their contracts renegotiated



with an average savings per family of \$13,500. He currently serves on the board of Austin Coming Together (ACT) and as a Visiting Scholar at Loyola University's Center for Urban Research and Learning (CURL).

Deborah has more than 20 years of experience as a community development practitioner. She is currently a Senior Program Officer at the Polk Bros. Foundation, where she is a program area leader for workforce development, affordable housing, community economic



development and safe communities. In 2010 she was awarded an Association of Black Foundation Executives fellowship. Deborah has served on a number of non-profit boards. She is currently a board member of the Chicago Low-Income Housing Trust Fund and Growing Home and is on the leadership committee of the Preservation Compact and the Chicagoland Workforce Funder Alliance.

Matt joined Neighborhood Housing Services of Chicago (NHS) in 2006. As NHS' Program & Grant Administrator, he currently helps facilitate the implementation of more than \$5 million in public and private programs that support homeownership and residential building rehab in



Chicago. He is also responsible for managing NHS' Chicago Greystone & Vintage Home Program (CGVHP), a historic preservation and cultural heritage-based education and technical assistance program aimed at encouraging reinvestment on Chicago's South and West Sides. In 2013, the CGVHP, NHS' North Lawndale neighborhood office, and the Lawndale Historical and Cultural Society initiated a series of programs exploring the history, impact, and community response to contract selling that culminated in a 2015 exhibit on the Contract Buyers League.
