#### **Member Updates**

Lydia Scott from The Morton Arboretum announced they have finalized part of their urban tree canopy analysis in four different counties. To celebrate their accomplishments they will be planting 30 trees in the city of Blue Island on April 23<sup>rd</sup>. Folks are encouraged to join them in this fun event. Molly Oshun from CNT announced that RainReady will be expanding its program to six more communities in the Calumet region—Blue Island, Calumet City, Calumet Park, Dolton, Riverdale and Robbins—with the purpose of replicating the Midlothian experience. Additionally, she announced that the Natalie Creek Project in Midlothian was approved, representing a significant relief to people that suffer from urban flooding in the area.

John Watson from MWRD announced the agency is currently working on four new projects related to green infrastructure and flooding.

Byron Tsang from Chicago Park District informed the group about the advances in Big Marsh and the activities they have done to restore the brownfield. They recently got rid of a significant amount of invasive vegetation, and are now working on restoring the hydrology of the area. He added that 12 new bald eagles were seen in the area.

#### Summary and highlights of work planning results

Danielle Gallet from MPC began the conversation by giving a brief summary of CSC's activities and achievements over the last year. She also reminded the group of its' established mission and vision, identified fundamental challenges as well as its year one work plan initiatives and work groups. She also highlighted the feedback received from the group about the value of the CSC to-date. Danielle then began to outline the work planning process that the CSC has been engaged in during the first quarter of 2016. The purpose of this working planning process was to identify what new initiatives the CSC would be working on, and generate an increased focus on the external impact of the CSC's work in the region.




She also reiterated how the members of the CSC drove this work planning process themselves, and that the next work plan will be released later in April.



## **CSC** meeting structure

Gallet continued her presentation by reminding the CSC members about the increased focus on balance between the value and the impact of the CSC for the region. Additional resources and attention will be given to the work groups this year in order to drive new initiatives and increase beneficial impact for the CSC region, as demonstrated by the following image:



Gallet also acknowledged that based-on feedback from the proposed new meeting schedule during the March meeting, MPC is proposing an adjusted meeting schedule in order honor the desire of the CSC to continue to meet on a monthly basis. The monthly meetings of the CSC will remain as scheduled for the rest of the year. Starting in the month of May, the large group meetings that everyone is accustomed to will take place every other month. During the opposite every other month meetings, the meeting structure will be focused on and led by the four work groups. These new work group-focused meetings will feature presentations, group exercises and brainstorming designed

to assist the work groups with initiatives, issues and/or ideas they would like to soundboard with the larger CSC. Time will also be given during these meetings for the four individual work groups to meet and do work together. The main purpose of this structure is to give the work groups an additional opportunity to meet, check-in with the larger CSC and move forward with specific tasks and projects.

The overall response from CSC members was positive, and the proposed meeting structure was approved. Following demonstrates how the CSC meetings going forward will be divided.



### Work group chats: planning next steps

Each of the work group leads gave a quick update about the group's activities and initiatives. In addition, a handout was given out to all the attendees to provide them with an overview of each group's purpose and current and potential initiatives. After the work group updates, Danielle personally acknowledged Lyndon Valicenti from Foresight Design on the incredible work she did in helping organize the structure and success to-date of the CSC. It was Lyndon's expertise in how to form cohesive, and mutually beneficial collaboration that has provided a strong foundation for the CSC.

Following the special acknowledgement, all the members of the collaborative were congratulated on a successful completion of the work planning process, followed by a networking and socializing opportunity that included treats to celebrate all the hard work.

# Presentation: Friends of the Chicago River—Overflow Action

The final activity of the April CSC meeting featured a presentation by Anthony Cefali from Friends of the Chicago River about Overflow Action Days. This initiative seeks to minimize the amount of water that goes into the sewer system during or after a major rain event. This call to action asks citizens to make changes in the way they use and treat water in and around their homes in order to help avoid combined sewer overflows into the Chicago River system during and after a significant rain event takes place.
