Extended Member Update

WMO update & identifying projects for StormStore

Ryan Wilson, Metropolitan Planning Council Jen Jenkins, The Nature Conservancy

Ryan delivered news that MWRD has updated their Watershed Management Ordinance (WMO) to remove prominent barriers to credit trading in Cook County. This enables StormStore, a partnership between TNC and MPC, to begin seeking partners within the Lower Des Plaines and Little Calumet watersheds for their Credit Trading Pilot. Ryan and Jen outlined criteria for participants, which include geographical, size-based, and topographical requirements. A full list can be found here. Chi-Cal Rivers Fund 2020: Navigating an Abbreviated Application Process

The Chi-Cal Rivers Fund is a public-private partnership which has invested over \$28 million in Chicago-area projects since 2013. There will be \$1 million available for grant funding in 2020, with a typical grant size of \$100,000 to \$300,000. Grants usually last 24 months, or two field seasons. The types of projects that are prioritized for funding are those that center habitat quality, green stormwater infrastructure, and public access improvements. Eligibility requirements and additional guidance is available on the Chi-Cal Rivers Fund RFP Page.

The application process has changed slightly for 2020. Specifically, there is no pre-proposal for grant funding. Grants made by the Chi-Cal Rivers Fund do not require match funding, but applications with 1:1 match are more competitive. Match can be federal or non-federal, other grants, in-kind services, land acquisition, volunteer activities, and more. Because there is no pre-proposal this year, Traci Giefer (<u>Traci.Giefer@NFWF.ORG</u>) and Aislinn Gauchay (<u>Aislinn.Gauchay@NFWF.ORG</u>) encourage applicants to reach out with any questions; they want to help you submit a competitive application. Awards will be made in November, with no other delays expected. <u>Guidelines for competitive applications and answers to frequently asked questions can be found in the meeting presentation.</u>

IDNR Coastal Management – Competitive Grants Program

Ania Bayers, IDNR Coastal Management Program

The IDNR Coastal Management Program (CMP) works to protect and enhance the environmental, economic, and social value of Illinois' Great Lakes coast, fostering healthy ecosystems and resilient communities. IDNR CMP has awarded over \$5.5 million in grants to 60 grantees, with individual grants ranging from \$3,000 to \$100,000. In the past, competitive grants have been predominantly focused on education and outreach (71%), planning (25%), and restoration (4%).

In 2020, a Request for Proposals will likely go out in October or November, and the pre-application will likely be due in January. A pre-application decision will be made by March, and selected applicants will be invited to submit a full application, which will be due in April and May (45 days after notification). The grant period covers 18 months, from Fall 2021 to Spring 2023. IDNR CMP funding comes in the form of a reimbursement grant, meaning that there are no advance payments. A 1:1 in non-federal match is required for most projects, with the exception of economically challenged communities, where a grant can cover 75% of the total cost (1:3 match).
