Calumet Collaborative: Bi-state, sustainable development, and a Brownfield Initiative update

Theme: Advancing the CSC's Goal 3 to increase municipal capacity and reduce fragmentation across Calumet government actors

The Calumet Collaborative works with a host of organizations throughout the three counties of NW Indiana and the Calumet River and southern Lake Michigan watersheds in Illinois to advance goals related to Economic Opportunity, Livable Communities, Culture & Heritage, and Environment. They achieve this mission by convening work groups, partnering to build local capacity, facilitating meetings, and supporting the work being done by other organizations. Some example projects include a wayfinding and branding initiative for the Calumet Heritage Area (or, once approved by Congress, the Calumet National Heritage Area), advocacy for Burnham Multimodal Connector (BMC) Bridge, the [Calumet Heritage Area Calendar](#), and the Brownfield Mapping Project.

The Brownfield Mapping Project was of particular interest because of its similarity to and potential overlap with the CSC's ongoing Green Infrastructure Baseline Inventory project. The Calumet Collaborative and their partners are working to identify and map the location of brownfields and underutilized lands to advance sustainable redevelopment in the Calumet region. The toolkit will include other datasets, such as land use categories, zoning classifications, water features and infrastructure to think about relationships between the sites and assist in decision-making. Upon completion, they will work with partners to determine how to roll out the tool. Check the presentation slides to see how the inventory is shaping up.

Work Group Update: Data & Modeling and Planning & Policy

Theme: Advancing the CSC's Foundational Activity 1 to establish baseline of existing green infrastructure.

As part of Phase 1 of the [CSC's 3-Year Work Plan](#), a group of technical advisors has met since January to consider the feasibility and need for establishing a baseline understanding of where green infrastructure exists throughout the Calumet region. In early meetings, the group discussed why something like this would be needed and who would use it. Through discussions, it was decided that a dataset of points (not polygons) should be the first priority. Later, an online map or custom-built tool could be possible. The advisors developed a list of must-have and would-be-nice-to-have attributes for the dataset and discussed a geographic scope in which to focus future efforts. Specifically, the efforts should start on the Illinois side of the Calumet region for now and not extend west past Orland Park. Again, the initiative may later be extended beyond this initial scope. For green infrastructure types, inclusion of a GI installation should be driven by several drivers, including being built to perform in a certain level of storm event as well as considerations related to scale, focus, intentionality and benefits.

Next steps: MPC will package the recommendations of the technical advisors into a report to IDNR with the proposed scope of work, recommendations for hosting and maintenance, and potential funding agencies for the next phase of work.
